## Handling Changes to MI Part Core Tax on Manager SE Estimate/R.O./Invoice

**Summary**: In Michigan parts are taxable, however a change in 2017 Michigan law mandates taxes no longer be collected on cores. However the core activity must still be recorded on the final invoice as TWO LINES, <core> AND <core return> and <u>cannot</u> be included in actual part cost itself.

This document is intended to assist in preparing invoices in Manager SE that comply with this tax change.

- Page 1: How catalog part Transfer function adds <core> line [below]
- Page 2: Handling taxable (retail) customers
- Page 3: Handling non-taxable (resale or other tax exemption) customers

A) During catalog transfer, Manager SE first asks the user to confirm if a core is to be included with the part; when the user answers 'Yes', the core value appears on the order as a separate line item (below).


